- Interaction data within Stratbox (e.g., pages visited, strategies activated).

Communications

Any direct messages or inquiries sent to our support email.

3. How We Use Your Information

Service Provision

■ To authenticate you, connect to your MT5 accounts, and enable automated strategy execution.

o Platform Security

■ To detect, prevent, and address technical or security issues.

Service Improvements

■ To analyze usage trends, improve user experience, and develop new features.

Legal Compliance

■ To comply with applicable laws and regulations or respond to lawful requests by public authorities.

4. Data Sharing and Disclosure

No Selling of Personal Data

We do not sell, rent, or trade your personal information to third parties.

Third-Party Service Providers
