## 1. Acceptance of Terms

By accessing or using Stratbox.io ("Stratbox," "we," "us," or "our"), you ("User," "you," or "your") agree to be bound by these Terms of Service ("Terms") and our Privacy Policy. If you do not agree, do not access or use our services.

We do not hold or manage any user funds. Users connect their MT5 broker accounts to our platform by providing valid credentials.

### 4. Execution Responsibility

Users retain full responsibility for any trades executed through Stratbox. We do not assume liability for any orders, profits, or losses.

## 3. User Accounts and Credentials

### 1. Account Registration

You must create a Stratbox account with accurate, complete, and up-to-date information. You are responsible for maintaining the confidentiality of your account credentials.

### 2. MT5 Credentials

You must provide valid MT5 broker account credentials so our secure cloud servers can execute your chosen trading strategies. You remain solely responsible for all actions taken under your MT5 accounts.

### 3. Security Obligations

You agree to immediately notify us of any suspected unauthorized access to your account. We reserve the right to suspend or terminate access to protect account security.

## 4. Platform Usage

### 1. Limited License

We grant you a personal, non-transferable, non-exclusive license to access and use our cloud-based MT5 environment for your internal business or personal trading purposes.

### 2. User Responsibilities

- You are solely responsible for monitoring and managing the strategies you activate.
- All risk, losses, or costs associated with trading remain yours.
- You acknowledge that using automated strategies does not guarantee profits and may result in substantial losses.

### 3. No Support for Final Customers or Brokers

- **Strategy Support:** Any questions or issues related to specific trading strategies must be addressed to the respective strategy provider. Stratbox does not provide direct support to final customers for strategy-related matters.
  - **Broker Support:** Stratbox does not provide support for any broker-related issues. All broker-related concerns must be directed to the broker.
